Many pest species enter the building through exterior walls or relocate through interior adjoining walls. It is critical to properly treat these walls to kill these overwintering and trans-locating species. Treat walls by removing outlet and switch plate covers then puffing a light coating of dust into the wall voids behind the outlet boxes (not in the boxes themselves). This applies a layer of dust onto the tops of the electrical cables inside the walls, which is a common 'highway' for bugs to traverse. Also treat gaps around cracked interior and exterior window and door frames; this will allow dust to flow into the wall voids and cracks around the molding. These are common entrance points into a structure. Wipe away excess dust with a damp cloth to ensure your applications are inaccessible to future human/pet contact, but remain in the hiding places of the pests.
