#### DIRECTIONS FOR USE

Read entire label prior to use and use product as directed. Shake well before use or dilution. To minimize foaming, add water to spray tank first; then add this concentrate. For severe infestations dilute 1 part concentrate {or use product name} to 9 parts water. For maintenance treatments dilute 1 part concentrate {or use product name} in up to 39 parts water. For use in pump-up and trigger sprayers.

**Pantries, cupboards, closets:** Before applying product to pantry, cupboards, cabinets or closets, remove items to allow best access and prevent treating non-target items. Directly contact harboring pests. Repeat as necessary.

**For general indoor treatments:** Set nozzle on the "spray" setting and directly spray pests. Adjust the nozzle to the "stream" setting and directly spray pests hiding in cracks and crevices throughout the house, including cracks behind baseboards, cracks inside of furniture and cracks/crevices around cabinets. Also spray any accessible areas behind appliances and cabinets, around trash cans, around window and door frames, and in attics/basements/crawlspaces.

**For outdoor perimeter treatments:** Before applying to outside perimeter of a structure, rake back mulch, debris and leaf litter to expose the ground (nesting areas). Directly spray pests, focusing your efforts on at least a 12" band along the entire perimeter. Pay close attention to the base of the foundation (the crack where the soil dries and pulls away

from the foundation). This expansion crack is a key harborage and traveling location for manypest species. To reduce pests' access into structures, cut back vegetation and branches that touch the foundation and minimize any rocks, wood piles and other potential harborages that are close to, or against, the building. Also spray around window and door frames, vents, utility lines entering the structure and along the eaves. Repeat as necessary.
