DIRECTIONS FOR USE

Read entire label prior to use and use product as directed. Shake well before use or dilution. To minimize foaming, add water to spray tank first; then add this concentrate. **For severe infestations** dilute 1 part concentrate {or use product name} to 9 parts water. **For maintenance treatments** dilute 1 part concentrate {or use product name} in up to 39 parts water. For use in pump-up and trigger sprayers.

Throw away all unneeded items and organize remaining items to limit bed bug hiding spots. Thoroughly vacuum furniture, flooring, bedframes, mattresses, box springs, baseboards, curtains and any other reachable areas. For suitable fabrics, clean all bedding, clothes, curtains, dressings, sheets, pillowcases, pillows, bed skirting and other washables (see *Laundry Additive* directions below). Separate cleaned items from uncleaned items. If possible, steam fabric and furniture that cannot be washed or dry-cleaned. Seal vacuum bag contents and immediately remove from the dwelling.

Adjust nozzle to 'spray' and apply product to wet any bed bugs that are visible, such as along all tufts and edges of mattresses and box springs. Use the 'stream' setting to treat any cracks and crevices around areas where bed bugs

have been seen. Properlytreat all beds in the dwelling, including pet beds and pet resting areas, nearby cracks/crevices and baseboards. Do not come in contact with or use treated articles until spray has completely dried. It may be beneficial to either cover the mattress and box springs with a bed bug blocking encasement immediately after treatment dries, or replace the mattresses and box springs. Simultaneously wash/dry-clean or replace all sheets, bedding and clothing suspected of being harboring bed bugs. Treat wall voids, where feasible, with a dust product labeled for killing bed bugs, particularly if the walls are joined with other dwellings. When traveling, isolate and treat the luggage before bringing into the dwelling.

Laundry Additive: As a laundry additive to kill bed bugs add 1-2 capfuls of this product to your normal laundry detergent when washing clothes, bedding, sheets, etc. Use the highest heat possible. Dry normally, adding 30 minutes to time. After washing/drying, store clean articles only in places that have been thoroughly cleaned, vacuumed and treated with this product as directed above.
