Do not use under clothing. Hold spray nozzle about 8-12 inches from skin and/or clothing when spraying. Do not spray directly onto face; to apply to face, spray onto hands first, then apply to face, avoiding eyes. Do not spray over cuts, wounds or irritated skin or apply near eyes or mouth.
