#### **DIRECTIONS FOR USE**

Read entire label before use. Shake well before use.

Keep children and pets out of treated areas until sprays have dried.

Dilute 1 part concentrate with 4 parts water and mix thoroughly. This provides a solution containing 1% Cinnamon Oil, 1% Sodium Lauryl Sulfate and 1% Thyme Oil.

To Apply: Set sprayer nozzle to "spray" or "mist" setting and, with nozzle 6 inches from weeds/moss/algae to be treated, completely cover foliage with spray, but not to the point of run-off. For weeds, set sprayer nozzle to "stream" setting and spray three pumps or seconds at the base of the weed. Retreat hard-to-kill weeds after five days if there are no visible signs of plant kill. Protect desirable plants during application by shielding them with cardboard or plastic. If non-target plants are accidentally sprayed, immediately rinse the plants and surrounding area with large amounts of water.

When to Apply: Weeds, Moss and Algae: Apply when weeds are actively growing. For best results, apply during warm (above 60°F), sunny weather. Cloudy, cooler weather may delay or reduce this product's effectiveness. Spray only when air is calm to prevent drift to desirable plants. Retreat if it rains within 24 hours of spraying. Moss and Algae: Use on roof shingles, brick, decking, fencing, siding, stucco, stone, outdoor furniture, patios, walk ways, pavers, flower pots, driveways, sidewalks, pool decks and playground equipment. Persistent moss growth on lawns is symptomatic of too much shade, acid soil and poor drainage. If several sprayings do not reduce the moss problem, it may be necessary to reduce shade, aerate lawn and lime the soil.
